The Selectmen reviewed the Server Replacement Proposal dated 1/18/2018 in the amount of \$3,389.44 from Swifttide Technologies which is to be expensed to General Government Buildings- Repair and Maintenance. The replacement of the outdated software and server will allow Swifttide and Profund the ability to upgrade the recently released accounting software. Jamie made a motion to accept and sign the Server Replacement Proposal from Swifttide Technologies, seconded by Chris. All were in favor and the motion passed. The Selectmen reviewed and signed the DRA Forms for the 2018 Warrant Articles, 2018 MS-DTB (Default Budget) and MS-636 (Budget). Chris updated the Selectmen on the legal opinion letter to the Conservation Commission from Attorney Durbin on the Anderson Conservation Easement/Vernon.
